

# Cancellations Policy

## Bali Wellness Journey – 2024

October 31<sup>st</sup>- November 9<sup>th</sup>, 2024

In the event of cancellation by participants of Bali Wellness Journey – 2024:

### Refund/Cancellation Policy

- 90 days or more before travel - loss of deposit (\$830)
- 61 - 89 days before travel - 25% or loss of deposit (whichever is greater)
- 31- 60 days - 60% cancellation charge
- Less than 30 days before departure - 100% cancellation charge

In the event of cancellation by Debi Robinson Wellness LLC, Kate Horsburgh:

- In the event of cancellation by Debi Robinson Wellness LLC, Kate Horsburgh, your payment and deposit will be refunded 100%.
- In the event this retreat is canceled due to COVID/pandemic and travel restrictions, you will be refunded the monies minus the \$830 deposit.
- Please review your travel insurance documentation to make sure it covers Pandemic cancellation travel.
- Finalization/cancellation of retreat can occur up to 90 days prior to retreat.
- Please confirm that the retreat has reached minimum capacity before purchasing your airline tickets if required.

Yoga movements, postures, treatments, and other activities waiver:

If I contract COVID during the trip in Bali, (Debi Robinson Wellness LLC, Kate Horsburgh, Five Pillar Foundation, our tour company, our hotels and retreat centers in Bali, their officers, and employees) will not be held liable. I will place myself in quarantine at my own expense until I test negative from COVID before rejoining the tour. If I am sick past the date of the tour, I will need to stay in quarantine, at my expense, until I test negative for COVID to travel out of BALI.

The participant agrees to assume all risks associated with the Bali Wellness Journey – 2024 and agrees that no liability will attach to the Retreat Organizer and Retreat Center, their employees or agents, or to any member of the trip in respect of death, COVID, personal injury, illness or delay of the passenger, or for any loss of or damage to the property (including luggage) of the participant during the course of the Retreat, howsoever caused. By signing this Retreat Participation Agreement, the participant releases the Retreat Organizer as well as the Retreat Center and their representatives from any such responsibility or liability, except as herein above set forth.
